RESOLUTION NO. 18-31

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CASTLE
PINES, COLORADO APPROVING THE CANYONS FILING NO. 1, 1st
AMENDMENT FINAL PLAT; CASE NO. FP 18-002**

WHEREAS, the City of Castle Pines is authorized pursuant to Title 31, Article 23, C.R.S., the City of Castle Pines zoning and subdivision regulations as adopted via Ordinance No. 08-04, as amended (“Zoning Ordinance”), and the Canyons Subdivision Regulations (“Subdivision Regulations”) as adopted through Ordinance No. 09-18, to regulate the subdivision of land within the Canyons Planned Development; and

WHEREAS, to date, the Canyons Property has been platted into two superbloc plat (“Superblock Plat 1” and “Superblock Plat 2”) and one final plat known as the Canyons Filing No. 1 final plat, in conformance with the Subdivision Regulations; and

WHEREAS, Shea Canyons LLC (the “Applicant”), has submitted an application for a final plat to further subdivide Lot 1, Block 6, of the Canyons Filing No. 1 Final Plat (“Final Plat”); and

WHEREAS, the Final Plat covers property containing 21.39 acres, legally described as Lot 1, Block 6, Canyons Filing No. 1 Final Plat, City of Castle Pines, County of Douglas, State of Colorado (the “Property”); and

WHEREAS, the City Council considered the Final Plat during a duly noticed public meeting held on October 9, 2018; and

WHEREAS, the Applicant has agreed to all conditions of approval as stated in this Resolution; and

WHEREAS, the City Council has determined that the Final Plat meets all applicable requirements of the Zoning Ordinance and the Subdivision Regulations, subject to the conditions of approval as stated in this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO AS FOLLOWS:

Section 1. The recitals contained above are incorporated herein by reference and are adopted as findings and determinations of the City Council.

Section 2. The Final Plat designated as The Canyons Filing No. 1, 1st Amendment, Case No. FP18-002, is approved subject to the following conditions of approval which shall be satisfied prior to recordation of the Final Plat:

- a. The Applicant shall resolve any minor technical changes to the Replat/Final Plat mylar as directed by City staff; and
- b. The Applicant shall pay ALL fees and costs incurred by the City and its consultants, in the review and processing of the Replat/Final Plat application; and
- c. The Applicant shall finalize the Street and Stormwater Construction Documents covering all public improvements and finalize a Subdivision Improvements Agreement in a form approved by the City Manager; and.
- d. The Applicant shall provide evidence of vacation of Parker Water & Sanitation District easements that overlap with and encroach on public right-of-way in The Canyons Filing No. 1, 1st Amendment.

Section 3. The Mayor is hereby authorized to sign the Final Plat exhibit upon final review and approval as to form by the Community Development Director and the City Attorney.

Section 4. Effective Date. Approval of the Final Plat shall be deemed effective upon its recordation in the office of the Douglas County Clerk and Recorder.


