RESOLUTION NO. 18-33

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CASTLE
PINES, COLORADO APPROVING THE CANYONS FILING NO. 2
FINAL PLAT; CASE NO. FP 18-004**

WHEREAS, the City of Castle Pines is authorized pursuant to Title 31, Article 23, C.R.S., the City of Castle Pines zoning and subdivision regulations as adopted via Ordinance No. 08-04, as amended (“Zoning Ordinance”), and the Canyons Subdivision Regulations (“Subdivision Regulations”) as adopted through Ordinance No. 09-18, to regulate the subdivision of land within the Canyons Planned Development; and

WHEREAS, Shea Canyons LLC (the “Applicant”), has submitted an application for a final plat to subdivide Parcel 9 of The Canyons Superblock Plat 2 and Lot 1, Block 13 of The Canyons Filing No. 1 (“Filing No. 2 Final Plat”); and

WHEREAS, the Filing No. 2 Final Plat covers property containing 173.078 acres as legally described in the attached **Exhibit A** (the “Property”); and

WHEREAS, the City Council considered the Filing No. 2 Final Plat during a duly noticed public meeting held on November 13, 2018; and

WHEREAS, the Applicant has agreed to all conditions of approval as stated in this Resolution; and

WHEREAS, the City Council has determined that the Filing No. 2 Final Plat meets all applicable requirements of the Zoning Ordinance and the Subdivision Regulations, subject to the conditions of approval as stated in this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO AS FOLLOWS:

Section 1. The recitals contained above are incorporated herein by reference and are adopted as findings and determinations of the City Council.

Section 2. The Final Plat designated as The Canyons Filing No. 2, Case No. FP18-004, is approved subject to the following conditions of approval to be satisfied prior to recordation of the Final Plat:

- a. The Applicant shall pay all fees and costs incurred by the City and its consultants, including without limitation legal fees and costs, for review and processing of the Final Plat application within forty-five (45) days of receiving an invoice from the City. If the fees and costs are not paid within forty-five (45) days of receiving an

invoice, the City may withhold issuance of building permits or further approvals until the invoices have been paid; and

- b. The Applicant shall resolve/correct any minor technical issues as directed by Staff; and
- c. The Applicant shall finalize and execute a Subdivision Improvements Agreement in a form approved by the City Attorney and shall finalize the Street and Stormwater Construction Documents as approved by the City; and
- d. The Canyons Filing No. 1 Plat shall be recorded in the office of the Douglas County Clerk and Recorder and such recording information shall be inserted as appropriate on the Final Plat and in Exhibit A of this Resolution; and
- e. The Applicant shall comply with such conditions that are imposed by motion of City Council at the public hearing to satisfy the criteria of approval set forth in the Subdivision Regulations and to meet the goals of the Comprehensive Plan.

Section 3. The Mayor is hereby authorized to sign the Canyons Filing No. 2 Final Plat exhibit upon satisfaction of the foregoing conditions of approval and upon final review and approval as to form by the Community Development Director and the City Attorney.

Section 4. Effective Date. Approval of the Final Plat shall be deemed effective upon its recordation in the office of the Douglas County Clerk and Recorder.
