

**RESOLUTION NO. 20-19**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO, TO EXERCISE THE CITY'S OPTION TO OPT OUT OF THE TRI-COUNTY HEALTH DEPARTMENT PUBLIC HEALTH ORDER REQUIRING THE USE OF FACE MASKS**

**WHEREAS**, the City of Castle Pines ("City") took quick and decisive action at the beginning of the pandemic response to ensure the life, safety and health of its citizens therefore making a significant contribution to reducing the risk of infection within our City; and

**WHEREAS**, the City provided both physical and informational resources including issuing over 8000 masks and developing a first-class resource site on the City home page linking to numerous information sources that served as a one-stop shop for the citizens of Castle Pines; and

**WHEREAS**, our citizens have demonstrated their effectiveness at flattening the curve, and have time and time again, through this pandemic, shown that they are making fantastic personal health choices and are great neighbors within our community, and within Douglas County; and

**WHEREAS**, we believe in and trust our citizens to make the best choices for themselves and their families, and it is the role of this Council to support them in that effort; and

**WHEREAS**, this City has a fantastic relationship with the Douglas County Sheriff's Department who provides professional and courteous service to our citizens through a substantial appropriation from our annual city budget and appreciates their educational approach and supports the right of our business owners to deliver service in a manner the owner sees fit concurrent with existing city ordinances;

**THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CASTLE PINES, COLORADO, THAT:**

**Section 1.** The City Council hereby directs City Staff to develop the necessary legal documentation officially exercising the opt out provision in the latest Tri-County Health Department Public Health Order requiring face coverings by July 23, 2020.


**Section 2.** Effective Date. This Resolution shall take effect upon its approval by the City Council.
