

RESOLUTION NO. 20-40

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF CASTLE PINES, COLORADO
APPOINTING MEMBERS TO THE CASTLE PINES PARKS AND
RECREATION ADVISORY BOARD**

WHEREAS, the City Council adopted Ordinance No. 19-09 as codified in Article 10 of Chapter 2 of the Municipal Code establishing a Parks and Recreation Advisory Board (the “Board”); and

WHEREAS, the Board is to be composed of seven members who are charged with the powers and duties set forth in Section 2-10-20 of the Municipal Code; and

WHEREAS, in accordance with Section 2-10-30 of the Municipal Code, the seven-member Board shall include two ex officio non-voting members including one member of City Council and the City Manager or his or her designee, and the remaining five of whom are at large members of the community, including one youth between the ages of fourteen and seventeen; and

WHEREAS, the City has advertised to fill the at-large and youth at-large seats on the Board and has interviewed all applicants; and

WHEREAS, there were no youth applicants to fill the youth at-large position; and

WHEREAS, from the pool of qualified applicants for the four at-large seats, the City Council desires to make appointments as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO, THAT:

Section 1. The City Council hereby appoints the following citizen representatives to serve on the inaugural Parks and Recreation Advisory Board:

Shannon Dryfuss – 3 year term expiring on October 13, 2023;

Stewart Larson – 3 year term expiring on October 13, 2023;

Betsy Steelman – 2 year term expiring on October 13, 2022;

Tiffany Ball - 2 year term expiring on October 13, 2022.

Section 2. The term of appointment for each such at large representatives shall be as stated in Section 1 above.

Section 3. This Resolution is effective upon adoption.
