

ORDINANCE NO. 20-03

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CASTLE PINES,
COLORADO, ADDING A NEW SECTION 2-2-100 TO THE CASTLE PINES
MUNICIPAL CODE CONCERNING COMPENSATION FOR FUTURE CITY
COUNCIL MEMBERS IN ACCORDANCE WITH SECTION 2.9 OF THE HOME RULE
CHARTER**

WHEREAS, the Home Rule Charter (“Charter”) of the City of Castle Pines provides at Section 2.9 that the City Council shall receive such compensation and associated benefits as may be prescribed by ordinance; and

WHEREAS, Section 2.9 of the Charter further provides that any compensation or associated benefits of any member of the City Council shall not be increased or decreased in any term of office during which the increase or decrease is approved by the City Council; and

WHEREAS, the Mayor and members of City Council currently receive no compensation for their public service as elected officials; and

WHEREAS, in recognition of the time and expense incurred serving as public officials of the City, City Council desires to establish monthly compensation to commence during the next term of the duly elected Mayor and the next term of each of the duly elected members of City Council.

**THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO,
ORDAINS:**

Section 1. The recitals contained above are incorporated herein by reference and are adopted as findings and determinations of the City Council.

Section 2. A new Section 2-2-100 is hereby added to Article 2, Chapter 2 of the Castle Pines Municipal Code as follows:

Sec. 2-2-100. – Compensation of Mayor and City Council.

- (a) The Mayor shall receive as full compensation a stipend of \$1,100.00 per month in accordance with Section 2.9 of the Charter.
- (b) Each Councilmember shall receive as full compensation a stipend of \$750.00 per month in accordance with Section 2.9 of the Charter.

Section 3. **Publication and Effective Date.** The City Clerk is hereby directed to cause publication of this Ordinance in accordance with Section 6.5 of the Charter. This Ordinance shall be effective thirty (30) days after final publication on the City’s official website and posting at the City Clerk’s office pursuant to Section 1-3-40 of the Municipal Code.
