

ORDINANCE NO. 13-07
AN ORDINANCE AMENDING SECTION 2-3-50 AND SECTION 2-3-60
OF THE CITY OF CASTLE PINES MUNICIPAL CODE AS A RESULT
OF THE PASSAGE OF BALLOT QUESTION 2F AT THE
NOVEMBER 5, 2013 ELECTION RECLASSIFYING THE POSITION OF
CITY CLERK FROM AN ELECTED OFFICE TO AN APPOINTED POSITION

WHEREAS, on November 5, 2013, the voters of the City of Castle Pines ("City"), at a regular election, approved ballot question 2F, changing the position of City Clerk from an elected office to an appointed position; and

WHEREAS, changes to Sections 2-3-50 and 2-3-60 of the Municipal Code are necessary to reflect the change in status of the position of City Clerk to be effective as of January 13, 2014.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO:

Section 1. Section 2-3-50, titled *City Clerk*, of the Castle Pines Municipal Code is hereby amended to read in full as follows:

Sec. 2-3-50. City Clerk.

Effective as of January 13, 2014, the position of City Clerk shall be reclassified from an elected office to an appointed position. The City Council authorizes the City Manager to hire a City Clerk in accordance with Section 2-3-70(c)(2) of this Article. The employed City Clerk shall have those powers and duties as required by ordinance, or as assigned by the City Manager.


Section 2. Section 2-3-60, titled *City Clerk; duties; city seal*, of the Castle Pines Municipal Code is hereby amended to delete the last sentence in subsection (a) and to delete the last sentence in subsection (b), with all other provisions of Section 2-3-60 to remain in effect.

Section 3. **Severability.** If any section, paragraph, clause, or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining provisions of this Ordinance, the intent being that the same are severable.

Section 4. **Effective Date.** This Ordinance shall take effect and be in force thirty (30) days after publication following final adoption.
