

ORDINANCE NO. 16-07

**AN ORDINANCE AMENDING SECTION 2-2-80 OF CHAPTER 2 OF THE
CITY OF CASTLE PINES MUNICIPAL CODE
REGARDING CITY-DESIGNATED PLACES OF POSTING NOTICES**

WHEREAS, the City of Castle Pines is a statutory municipality organized pursuant to Article 4 of Title 31 of the Colorado Revised Statutes; and

WHEREAS, in accordance with Section 24-6-402(2)(c), C.R.S., the City is required to provide full and timely notice in advance of its public meetings; and

WHEREAS, Section 24-6-402(2)(c) further provides that such full and timely notice shall be deemed to have been given if it is posted in a designated public place or places within the boundaries of the City no less than twenty-four hours prior to the holding of the meeting; and

WHEREAS, the City Council designates the public place or places for posting such notices at its first regular meeting of each calendar year by resolution in accordance with state law; and

WHEREAS, Section 2-2-80 (a) of the Castle Pines Municipal Code codified the place for posting public notices by designating the Castles Pines Community Center, 7404 Yorkshire Drive, as the official posting place; and

WHEREAS, the City's relocation of its offices to the Castle Pines Library, 360 Village Square Lane, Suite B, Castle Pines, Colorado 80108, necessitates an amendment to Section 2-2-80 of the Castle Pines Municipal Code.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO:

Section 1. Section 2-2-80, entitled *Posting notice of public meetings*, is amended to read in full as follows:

Section 2-2-80 – Posting notice of public meetings.

The City Council shall designate by resolution the place for posting notice of the public meetings of the City Council or any local body affiliated with the City at the first regular Council meeting of each calendar year. Additional or supplemental places for posting notices may be designated by resolution enacted by the City Council from time to time.

Section 2. Severability. If any section, paragraph, clause, or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining provisions of this Ordinance, the intent being that the same are severable.

Section 3. Effective Date. This Ordinance shall take effect and be in force thirty (30) days after publication following final adoption.


