A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO RENEWING AND APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, COLORADO REGARDING PUBLIC SAFETY AND ANIMAL CONTROL SERVICES

WHEREAS, Part 2 of Article 1 of Title 29 of the Colorado Revised Statutes, as amended, authorizes and enables governmental entities within the State of Colorado to enter into cooperative agreements or contracts with one another to provide such functions, services or facilities lawfully authorized to each of them; and

WHEREAS, the City of Castle Pines (the "City") previously entered into an intergovernmental agreement with the Board of County Commissioners of Douglas County, Colorado, (the "County") and the Douglas County Sheriff ("Sheriff") to provide law enforcement and animal control services by the Douglas County Sheriff within the boundaries of the City for 2009 and 2010; and

WHEREAS, the City, County and Sheriff wish to renew the agreement, in substantially the same form as attached hereto as **Exhibit A**, to continue to provide law enforcement and animal control services within the boundaries of the City for 2011.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO:

Section 1. That the City hereby approves the Intergovernmental Agreement between the City of Castle Pines, Colorado, and Board of County Commissioners of Douglas County, Colorado, on behalf of the Douglas County Sheriff's Office, in substantially the same form as attached hereto as **Exhibit A**, and hereby authorizes the Mayor to execute the Agreement.

Section 2. Effective Date. This Resolution shall take effect upon its approval by the City Council.

EXHIBIT A INTERGOVERNMENTAL AGREEMENT

INTERGOVERNMENTAL AGREEMENT FOR PUBLIC SAFETY SERVICES

THIS AGREEMENT made and entered into this day of the State of Colorado (hereinafter referred to as "the City"), and the Board of County Commissioners of the County of Douglas (hereinafter referred to as the "Board"), on behalf of the Douglas County Sheriff's Office (hereinafter referred to as the "Sheriff"), hereinafter collectively referred to as the "County".

WITNESSETH:

WHEREAS, Section 30-1 1-406(c), C.R.S., authorizes the Board to contract with the City for the purpose of providing law enforcement by the Sheriff within the boundaries of the City; and

WHEREAS, Section 29-1-203, C.R.S., authorizes the City to enter into contracts with other governmental units for services; and

WHEREAS, the City, Sheriff and Board previously entered into an intergovernmental agreement for the provision of law enforcement and animal control services for 2009 and 2010; and

WHEREAS, the City, Sheriff and Board desire to renew the agreement for the provision of law enforcement and animal control services in accordance with the terms herein provided;

NOW, THEREFORE, in consideration of the premises, it is agreed as follows:

- 1. The County shall provide law enforcement and animal control services within the boundaries of the City commencing January 1, 2011.
- 2. The type of law enforcement services to be provided by the Sheriff within the boundaries of the City shall be substantially similar to the routine or non-extraordinary law enforcement services provided in the unincorporated areas of Douglas County, including but not limited to providing random police patrols, traffic enforcement including speeding and other moving violations, municipal court attendance pursuant to duly issued subpoenas, call response, ordinary criminal investigations, K-9, and SWAT team response services, and the Sheriff shall utilize, to the best of his ability and judgment, the manpower and equipment presently at his disposal in order to provide said services.
- 3. It is understood that unanticipated, non-routine and extraordinary events or investigations ("Extraordinary Events") may arise. The Sheriff shall notify the Mayor of the City immediately when an Extraordinary Event arises requiring additional police protection through the Sheriff. Extraordinary Events shall include, but are not limited to, homicides, large fires or other natural disasters, house-to-house searches for fugitives and other non-routine or unanticipated emergency situations. Extraordinary Events shall not include routine law

enforcement services relating to concerts or other entertainment gatherings within City limits, unless such events give rise to an Extraordinary Event, such as a riot or fire. The City and the Sheriff shall cooperate in determining the scope of law enforcement services required to respond to any Extraordinary Event.

- 4. The County shall also provide routine traffic control, traffic enforcement, and animal control services within the boundaries of the City. The County is hereby authorized to enforce all Douglas County ordinances pertaining to the regulation of traffic and parking, resolutions for the control and licensing of dogs and pet animals, and such County ordinances and resolutions as may be adopted and amended from time to time as expressly approved by the City Council pursuant to Section 30-15-401(8), C.R.S., inclusive as of the date of this Agreement of Ordinance Numbers: 996-002 (Door to Door Solicitations); 001-003 (Minor Tobacco Possession); 002-001 (Solicitation in Roadways); 003-001 (Open Fires); 007-001 (Curfew); and 007-003 (Sidewalk Snow Removal). The City shall be entitled to retain all revenue collected as a result of such enforcement within the City and will be responsible for subsequently paying any applicable surcharges collected to the appropriate agency.
- 5. The Sheriff agrees to consider, on a case-by-case basis, requests for enforcement of municipal ordinances, including but not limited to parking violations, as may be designated from time to time by the City. The Sheriff is authorized, but not obligated unless the parties agree in writing, to enforce the City's ordinances. In the event jail or related services are necessary in conjunction with the enforcement of such ordinances, those services shall be subject to normal and customary fees as established by the County.
- The term of this Agreement shall commence January 1, 2011, and shall terminate on December 31, 2011.
- 7. The City shall pay to the Douglas County Law Enforcement Authority Fund the total sum of \$706,266.86 which amount is equal to a 4.5 mill levy for all of the 2010 assessed valuation (\$156,948,190) within the boundaries of the City. The City shall also pay the Douglas County General Fund the total sum of \$39,836.00 for animal control services. In lieu of the net property tax, auto ownership tax and short-term rental tax collections being distributed directly to the City, such amounts shall be retained by the Board and applied to the sum of \$746,102.86 (\$706,266.86 for law enforcement services and \$39,836 for animal control services) until paid in full. Should actual net property tax, auto ownership tax and short-term rental tax collections surpass the sum of \$746,102.86, any additional funds collected will be remitted directly to the City on the 10th of the subsequent month. Should actual net property tax, auto ownership tax and short-term rental tax collections not be sufficient to pay the total sum of \$746,102.86 by December 31, 2011, the City shall remit any balance due to the Douglas County Treasurer's Office no later than January 31, 2012. "Net property tax collections" is defined as the amount of current and prior year real and personal property taxes and interest collected, offset by the amount of any abated real and personal property taxes, and offset by one percent (1%) of all actual property tax collections retained by the Douglas County Treasurer's Office per Section 30-1-102, C.R.S.
- The Sheriff shall provide the City with quarterly statistical reports reflecting calls for service and crime statistics.

- 9. The County shall provide to the City proof of insurance coverage for losses, costs, damages, claims, actions or liability which may arise or grow out of the Sheriff's provision of police protection, law enforcement services, and animal control services as a result of the actions of himself, his staff, or any of his deputies or agents; however, such insurance coverage shall not extend to and the County assumes no responsibility for actions of personnel, staff, representatives, agents or elected officials of the City.
- This Agreement may be renewed or renegotiated at the end of the term upon mutual agreement of the parties.
- 11. NO WAIVER OF GOVERNMENTAL IMMUNITY ACT. The Parties hereto understand and agree that the County, it commissioners, officials, officers, directors, agents, and employees, are relying on, and do not waive or intend to waive by any provisions of this Agreement, the monetary limitations or any other rights, immunities and protections provided by the Colorado Governmental Immunity Act (the "CGIA"), § 24-10-101 to 120, C.R.S., or otherwise available to the County or the City. To the extent the CGIA imposes varying obligations or contains different waivers of immunity for cities and counties, both the City and the County agree that each will remain liable for their independent obligations under the CGIA, and neither party shall be the agent of the other or liable for the obligations of the other.
- 12. NO THIRD PARTY BENEFICIARIES. The enforcement of the terms and conditions of this Agreement and all rights of action relating to such enforcement shall be strictly reserved to the County and the City, and nothing contained in this Agreement shall give or allow any such claim or right of action by any other or third person under such Agreement.
- 13. ADDITIONAL SERVICES. In the event the City desires services, in addition to the services defined in this agreement, the City may make a written request, which will then be addressed and resolved with reasonable promptness and on mutually acceptable terms between the Parties. Such resolution shall be in writing.
- 14. NOTICES. Except as otherwise provided herein, all notices or payments required to be given under this agreement shall be in writing and shall be hand delivered or sent by first class mail, postage pre-paid, to the following addresses:
