ORDINANCE NO. 21-03

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO AMENDING SECTION 2-10-30 OF THE MUNICIPAL CODE CONCERNING MEMBERS OF THE PARKS AND RECREATION ADVISORY BOARD

WHEREAS, the City of Castle Pines has the legal authority, capacity and desire to provide parks and recreation services to the community; and

WHEREAS, the City is authorized pursuant to Article IX of its home rule charter to create boards and commissions by resolution or ordinance; and

WHEREAS, the City Council has established the City of Castle Pines Parks and Recreation Advisory Board via Ordinance No. 19-09, as codified in Article 10 of Chapter 2 of the Municipal Code; and

WHEREAS, among other responsibilities, the Parks and Recreation Advisory Board advises City Council in matters pertaining to parks and recreation programs and services; and

WHEREAS, to encourage broader participation by Castle Pines' residents, the City Council desires to amend the Board's membership to allow the option for Council to appoint a youth representative or an additional adult member.

NOW, THERFORE, BE IT ORDAINED by the City Council of the City of Castle Pines, Colorado:

<u>Section 1</u>. Section 2-10-30 of Chapter 2 of the Castle Pines Municipal Code is hereby amended to read as follows, with deletions shown in strike-through and additions shown in underline text:

Sec. 2-10-30. Membership; Terms of appointment; removal.

- (a) Membership and qualifications. The Parks and Recreation Advisory Board shall consist of seven (7) members as follows: (a) one (1) ex officio non-voting member who shall be a member of and selected by City Council; (b) one (1) ex officio non-voting member who shall be the City Manager or their designee; (c) five (5) four (4) at large members, one of whom may be a ; and (d) one youth at large member between the ages of fourteen (14) and seventeen (17) years of age at the time of appointment. The members four adult at large members and one youth member shall be appointed by City Council and shall be residents of the City. The at-large adult members shall represent a wide cross-section of the community to adequately represent the interests of all age groups and Council districts.
- (b) Terms. Voting members, except the youth member, shall serve for two-year terms, or until their successors are appointed and qualified. The youth member, <u>if one is appointed</u>, shall serve a term of at least one-year up to a two-year term. A maximum of three consecutive two-year

terms is allowed. The terms of voting members shall be staggered, with initial terms being two and three years.

- (c) Removal; vacancies. The City Council may remove a Parks and Recreation Advisory Board member at any time for any reason. City Council may fill any vacancy by appointment.
- <u>Section 2.</u> Severability. If any portion of this Ordinance is found to be void or ineffective, it shall be deemed severed from this Ordinance and the remaining provisions shall remain valid and in full force and effect, in accordance with Section 6.8 of the Charter.
- <u>Section 3.</u> No Existing Violation Affected. Nothing in this Ordinance shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any ordinance hereby repealed or amended by this Ordinance, or any just or legal right or remedy of any character be lost, impaired, or affected by this Ordinance.
- Section 4. Repeal of Previous Ordinances. Any and all ordinances or codes or parts thereof in conflict or inconsistent herewith are, to the extent of such conflict or inconsistency, hereby repealed; provided, however, that the repeal of any such ordinance or code or part thereof shall not revive any other section or part of any ordinance or code heretofore repealed or superseded and this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the effective date of this Ordinance.
- <u>Section 5.</u> Codification Amendments. The codifier of the City's Municipal Code is hereby authorized to make such numerical and formatting changes as may be necessary to incorporate the provisions of Section 1 of this Ordinance within the Castle Pines Municipal Code.
- Section 6. Safety Clause. The City Council hereby finds, determines, and declares that this Ordinance is promulgated under the general police power of the City of Castle Pines, that it is promulgated for the health, safety, and welfare of the public, and that this Ordinance is necessary for the preservation of health and safety and for the protection of public convenience and welfare. The City Council further determines that the Ordinance bears a rational relation to the proper legislative object sought to be obtained.
- <u>Section 7.</u> **Publication and Effective Date.** The City Clerk is hereby directed to cause publication of this Ordinance in accordance with Section 6.5 of the Charter. This Ordinance shall be effective thirty (30) days after final publication on the City's official website and posted at the City Clerk's office pursuant to Section 1-3-40 of the Municipal Code.
