

RESOLUTION NO. 21-29

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF CASTLE PINES, COLORADO
TERMINATING THE CITY OF CASTLE PINES DECLARATION OF EMERGENCY
RELATED TO NOVEL CORONAVIRUS (COVID-19)**

WHEREAS, pursuant to Resolution No. 11-32 and the authority granted under C.R.S. § 24-33.5-709, on March 16, 2020 the Mayor of Castle Pines, as principal executive officer of the City of Castle Pines, declared a local disaster and activated the emergency management operations plans and resolutions of the City related to the outbreak of COVID-19 (“Emergency Declaration”); and

WHEREAS, the Emergency Declaration is effective until the City Council determines an emergency no longer exists; and

WHEREAS, with the vaccination rate increasing throughout Douglas County, and the incidence rate of COVID-19 cases in steady decline, the City Council finds that the public health risks from COVID-19 no longer pose an emergency to the Castle Pines community, recognizing, however, that the City and the City’s business community continue to suffer from the devastating economic impacts of the COVID-19 pandemic; and

WHEREAS, City Council, therefore, has determined that a local disaster emergency no longer exists and desires to terminate the Emergency Declaration and the powers and authorizations granted in connection therewith.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO, THAT:

Section 1. The above recitals are hereby incorporated as findings by the City of Castle Pines City Council.

Section 2. The Emergency Declaration Related to Novel Coronavirus (Covid-19) is hereby terminated, including the powers and authorizations granted in connection therewith, except that nothing herein shall prevent or preempt the City, its residents or the City’s businesses, from economic relief through the receipt of local emergency funds and/or Federal and State assistance as it continues to suffer from the economic fall-out of the COVID-19 crisis; and

Section 3. This Resolution is effective upon adoption.
