**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CASTLE PINES,
COLORADO ADOPTING A REMOTE PARTICIPATION AND REMOTE MEETING
POLICY AND REPEALING RESOLUTION NO. 20-09**

WHEREAS, the City Council is authorized to adopt procedures and guidelines to govern the conduct of Council and City business; and

WHEREAS, the City Council has adopted procedures and rules of order under the authority of Section 3.9 of the Castle Pines Home Rule Charter; and

WHEREAS, due to the COVID-19 pandemic and the public health orders ensuing therefrom, the City Council adopted the Telephone/Electronic Meeting Participation Policy During Times of Emergency via Resolution No. 20-09 (“Emergency Electronic Meeting Policy”); and

WHEREAS, the Emergency Electronic Meeting Policy has allowed the City Council and its appointed boards and commissions to conduct public business and hold public meetings remotely through electronic means; and

WHEREAS, the City Council finds that remote/electronic meetings has generated broader public participation and attendance than only in-person meetings and that remote meetings in certain circumstances should continue to be provided; and

WHEREAS, the City Council desires to adopt the attached Remote Participation and Remote Meeting Policy to continue to allow remote participation and remote meetings as set forth in the attached policy, which shall supersede the Emergency Electronic Meeting Policy.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO:

Section 1. The City Council hereby adopts the Castle Pines Remote Participation and Remote Meeting Policy, attached hereto as **Attachment 1**, and repeals Resolution No. 20-09 in its entirety.

Section 2. The Remote Participation and Remote Meeting Policy adopted hereby replaces and supersedes the City of Castle Pines Telephone/Electronic Meeting Participation Policy During Times of Emergency adopted via Resolution No. 20-09.
