#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO APPROVING AMENDMENT NO. 1 TO A PROFESSIONAL SERVICES AGREEMENT WITH SAFEBUILT COLORADO, LLC RELATED TO BUILDING INSPECTION SERVICES

WHEREAS, the City of Castle Pines (the "City") is authorized to contract for performance of necessary public services including building official and code enforcement services; and

WHEREAS, the City and SAFEbuilt Colorado, LLC are parties to that certain professional services agreement for building official and inspection services approved by the City Council via Resolution No. 21-15 on March 23, 2021 ("Agreement"); and

WHEREAS, the City and SAFEbuilt desire to amend the Agreement to extend the term, amend the scope of services to include solar inspection and electrical inspection services, and to modify the compensation as set forth in the Amendment One to Professional Services Agreement ("Amendment One"), a copy of which is attached hereto as Exhibit 1.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO, THAT:

- Section 1. The City Council hereby: (a) approves the Amendment One with SAFEbuilt in substantially the same form as attached hereto and incorporated herein as Exhibit 1; (b) authorizes the City Attorney, in consultation with the City Manager, to make such changes as may be necessary to correct any non-material errors that do not increase the obligations of the City; and (c) authorizes the City Manager to execute the Agreement.
- <u>Section 2</u>. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining issues of this Resolution.
- <u>Section 3.</u> <u>Effective Date.</u> This Resolution shall take effect upon its approval by the City Council.

# AMENDMENT ONE AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN CITY OF CASTLE PINES, COLORADO AND SAFEbuilt COLORADO, LLC

This Amendment One ("Amendment") amends that certain Agreement for Professional Services previously entered into on March 29, 2021, by and between City of Castle Pines, Colorado, with offices at 7437 Village Square Drive, Suite 200, Castle Pines, CO 80108 ("City") and SAFEbuilt Colorado, LLC, a Colorado limited liability company, a wholly owned subsidiary of SAFEbuilt, LLC, ("Contractor"), with offices at 3755 Precision Drive, Suite 140, Loveland, CO 80538. City and Contractor shall be jointly referred to as the "Parties".

**Amendment One Effective Date**: Effective the first (1<sup>st</sup>) day of the month following full execution by both Parties.

#### **RECITALS AND REPRESENTATIONS**

Whereas, the Parties entered into an Agreement for Professional Services ("Agreement"), by which both Parties established the terms and conditions for service delivery on March 29, 2021; and

Whereas, the Parties hereto now desire to amend the Agreement as set forth herein; and

NOW, THEREFORE, for the consideration hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- A. Section II. A., Term, shall be amended to extend the Term through December 31, 2025, with the ability of the Parties to extend for up to two additional one-year terms as provided in Section II.A.
- B. Exhibit A, Scope of Services, is amended to include Solar Inspection Services and Electrical Inspection Services at the rates listed below.
- C. Agreement, Exhibit B, Compensation shall be amended to replace fees for plan review services and inspection services for building, mechanical and plumbing as follows:

Service Fee Schedule:	
Plan Review Services	60% of Municipal Plan Check Fee as established by ordinance or resolution
Inspection Services  • Building, Mechanical, Plumbing	60% of Municipal Permit Fee as established by ordinance or resolution
Inspection Services  • Solar and Electrical	80% of Municipal Permit Fee as established by ordinance or resolution

D. All other provisions of the Agreement shall remain in effect, to the extent not modified by this Amendment.
