RESOLUTION NO. 24-25

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CASTLE PINES, COLORADO, AMENDING THE CITY OF CASTLE PINES FEE SCHEDULE

WHEREAS, pursuant to Section 10.3 of Article X of the City of Castle Pines Home Rule Charter, the City Council shall determine, by resolution, the amount of any new City-imposed fee or change in the amount of any existing City-imposed fee for any service rendered by the City (specifically excluding franchise fees), based on the direct and indirect costs of providing services; and

WHEREAS, it is the intent of the City of Castle Pines to charge appropriate fees and charges (Collectively, the "Fees") that are consistent with the services provided and to cover the public cost of providing these various services so that the public is not subsidizing individual benefits derived therefrom; and,

WHEREAS, the current Fees include park rental and usage charges for City parks and facilities including but not limited to use of the Elk Ridge Park turf field; and

WHEREAS, the City Council desires to remove the "Non-Resident Team Participant" fee of \$12 per person per season listed below such that only the half field and full field rental fees for turf and multi-purpose field rental will apply:

Turf and Multi-Purpose Field Rental	
Half Field	\$24.00 per hour
Full Field	\$48.00 per hour
Non-Resident Team Participant	\$12.00 per person per season

WHEREAS, the City Council finds that the amended Fees as set forth herein will further the public health, safety and welfare of the community by easing the administrative burden on City staff for turf field rentals.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Castle Pines, Colorado, as follows:

- Section 1. Pursuant to authorization in the Castle Pines Municipal Code, the Castle Pines City Council hereby amends the Fees associated with "Turf and Multi-Purpose Field Rental" to remove the "Non-Resident Team Participant" Fee of \$12 per person per season in its entirety; and
- <u>Section 2.</u> <u>Effective Date.</u> The updated Fees established by this Resolution shall be effective upon adoption of this Resolution.
- Section 3. The Fees set by this Resolution shall supersede and replace any Fees previously set or adopted by the City Council for the same purpose. However, the same shall not be deemed to release, extinguish, alter, modify, or change in whole or in part any liability which shall have been previously incurred, and any superseded or replaced Fee shall be treated and held as remaining in force for the purpose of sustaining any and all proper actions, suits, and proceedings thereon, as well as for the purpose of sustaining any judgment, decree, or order.
- <u>Section 4.</u> If any portion of this Resolution is held to be invalid for any reason, such decision shall not affect the validity of the remaining portions hereof.
