Allow The City of Castle Pines unrestricted access to the site to conduct regular site inspections;2. Comply with all requirements of the GESC Manual, accepted GESC plan, and GESC permit;3. Immediately cease land-disturbing activities upon receipt of a written Stop Work Order from an authorized representative of The City of Castle Pines. A Stop Work Order shall be issued and this Permit revoked if the Permittees are not in compliance with the GESC Permit, GESC Plan and/or GESC Manual, or the Permittees fail to take corrective action within the time specified on the written notification of such non-compliance;4. Understand that in addition to other remedies, a violation of this GESC Permit shall constitute a violation of Section 31 of the City of Castle Pines Zoning Ordinance; and5.
