Process Requirement(s):

1. Based on the materials submitted, the proposed project will require a Rezoning – Planned Development (PD) application. Please see the Estimate for applicable fees and submittal requirements.

2. Rezoning (PD) applications require review by city staff as well as review by referral agencies. Staff will determine which agencies are to receive the referral.

3. The Rezoning (PD) application is required to be in conformance with the City of Castle Pines Zoning Ordinance for Planned Development District and Rezoning. Please see Regulatory Link(s): Planned Development District and Rezoning.

4. The final review and decision of the Rezoning (PD) application is by City Council, after a review and recommendation by the Planning Commission at scheduled public hearings. Public hearings will be scheduled by staff once the review of the Rezoning (PD) application is substantially complete, as determined by staff.

5. It is expected that the Rezoning (PD) application will require three reviews. The first review will be 23 business days, the second review is expected to be 18 business days, and the third review is expected to be 6 business days.
