

RESOLUTION NO. 25-36

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CASTLE PINES,
COLORADO, CONSENTING TO THE APPOINTMENT OF ASSISTANT MUNICIPAL
JUDGES TO SERVE WHEN THE PRESIDING MUNICIPAL JUDGE IS
UNAVAILABLE**

WHEREAS, pursuant to Section 2-4-30(d) of the Castle Pines Municipal Code, the presiding Municipal Judge may appoint assistant judges as necessary to conduct the business of the Municipal Court subject to the “advice and consent of the City Council”; and

WHEREAS, Judge Vincent White, as presiding Municipal Judge, desires to appoint the following assistant judges to conduct the business of the Municipal Court when he is unavailable: Beth Dumler, Kevin Ellman, Tom Ramunda and Virgina Robbins; and

WHEREAS, the City Council finds it is a best practice to maintain a list of Judge-recommended and Council-approved assistant judges who are available to preside over the Castle Pines Municipal Court in the event of a scheduling conflict, or when Judge White has a conflict with a specific case; and

WHEREAS, the City Council further finds that the individuals recommended by Judge White to serve as assistant (relief) judges are each qualified to serve in such role in the absence of Judge White.

**THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
CASTLE PINES, COLORADO, THAT:**

Section 1. The City Council hereby consents to the appointment of the following assistant municipal judges: Beth Dumler, Kevin Ellman, Tom Ramunda and Virgina Robbins.

Section 2. The City Council hereby establishes the compensation of assistant municipal judge at Five Hundred Dollars (\$500.00) per court session attended.

Section 3. If any section, paragraph, clause, or provision of this Resolution is held to be invalid or unenforceable by a court of competent jurisdiction, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining sections, paragraphs, clauses, or provisions of this Resolution.

Section 4. This Resolution shall take effect upon its approval by the City Council.
